Overview

Does KPMG have a 0% export duty rate in Argentina?

The KPMG member firm in Argentina also prepared this September 2025 report (Spanish) about this development. Furthermore, Decree No. 685, published in the Official Gazette on Septem, established a 0% export duty rate specifically for certain meat products, effective Septem, and until Octo.

Do you pay VAT on imports in Argentina?

Most goods imported into Argentina are subject to VAT. The tax will have to be paid by the importer at the time of importation. In addition, customs will collect VAT on this importation. Where the importation is for business purposes and the importer is registered for VAT, this tax is considered an input tax credit.

What are the exports of services in Argentina?

The exports of services are the services provided in the country where the effective use is carried abroad. Most goods imported into Argentina are subject to VAT. The tax will have to be paid by the importer at the time of importation. In addition, customs will collect VAT on this importation.

How would a 20% tax reduction affect Argentinian businesses?

Large taxpayers would benefit from a 20% reduction (24% effective tax rate). Reduction for micro and small businesses is 60% and for medium sized enterprises is 40%. This reduction would apply to both Argentinian and foreign-source income. Reduction to 0% on export duty applicable to exports of promoted services.

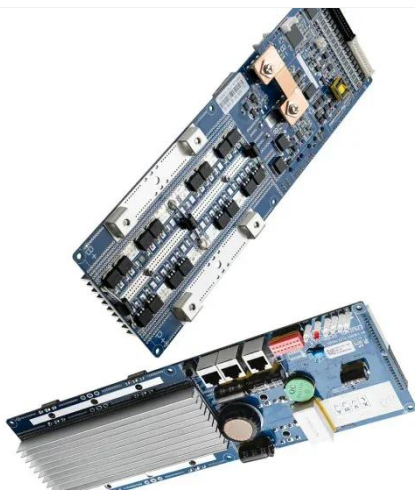
