# **Czech Brno power grid energy storage subsidies**



## Overview

What will the Czech electricity storage scheme do in 2025?

In an announcement released on Ma, the executive arm of the European Union said that the Czech scheme will support the installation of at least 1.5 GWh of new electricity storage facilities. The measure will be open to all storage technologies directly connected to the transmission network or distribution network.

How will Czech state aid help a net-zero economy?

The aid will take form of direct grants which will cover up to 50% of the investment cost of supported projects. From ESS News The European Commission (EC) has authorized a €279 million (\$303 million) Czech state aid scheme to support investment into electricity storage facilities and foster the transition towards a net-zero economy.

Why are Czech businesses investing in renewable projects without subsidies?

The subsidy increases to cover up to 75% of costs for community projects. But what we noticed at Wattstor is that Czech businesses are investing in renewable projects even in the absence of subsidies, because they have realised the strong business case for generating clean energy on site.

What incentives are there for onsite generation in the Czech Republic?

At the same time, stakeholder and regulatory pressure encouraged Czech organisations to invest in renewable power. There are several EU incentives to spur the growth of onsite generation. For example, the Modernisation Fund supports investments in energy efficiency, storage, network upgrades and the re-skilling of workers.
