How is a larcg frequency plan approved in Guyana?

Technical documents will be reviewed and validated in the approval process. Guyana has restrictions in the frequency band between 850 MHz and 999 MHz. LARCG will help determine if these restrictions apply to your equipment. National Frequency Allocation Table for Guyana establishes the frequency plan in Guyana.

What is the National frequency allocation table for Guyana?

National Frequency Allocation Table for Guyana establishes the frequency plan in Guyana. For products that do not require NFMU approval, the regulatory agency will provide a No Homologation letter to avoid any issues with customs. Guyana National Bureau of Standards.

Does Guyana require in-country product testing?

Guyana does not require in-country product testing, local representation, or specific product labeling. LARCG may use existing international test reports for the homologation process to obtain the NFMU approval. Technical documents will be reviewed and validated in the approval process.


