Are solar panels illegal?

Technically, no state outlaws or bans solar panels; quite the opposite. Most states have solar access laws that forbid any agreement, covenant, condition, bylaw, or contract that outlaws or limits solar installations by Homeowners Associations (HOA) or other municipal bodies.

Can a Hoa impose restrictions on installing solar panels?

These laws offer different levels of protection for homeowners who want to add solar panels. Twenty-two of these states allow HOAs to set reasonable rules for installation. The other seven states allow HOAs to impose other types of restrictions.

Can a Homeowners Association deny a solar panel installation?

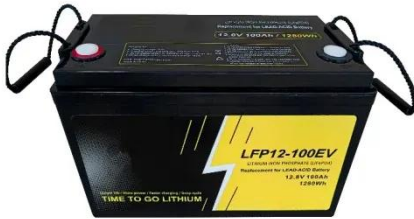
Associations can also ask homeowners to get approval before installing solar panels. The HOA cannot deny approval if the homeowner meets the solar energy requirements. They can only step in if installing it would cause nuisance or unreasonable discomfort to people with normal sensibilities.

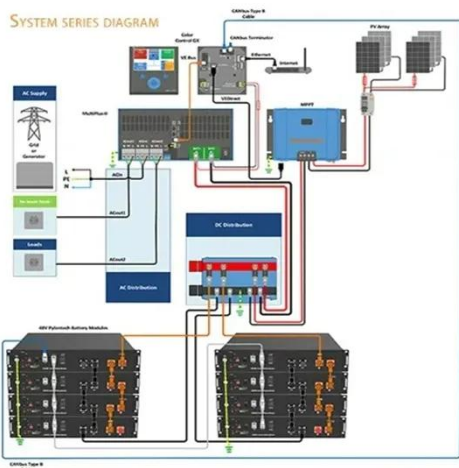

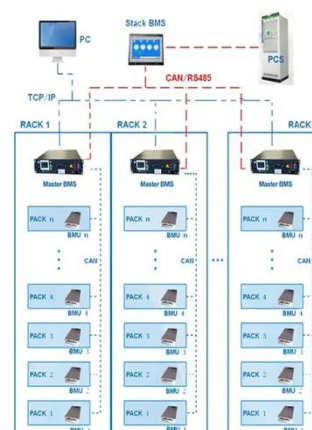
