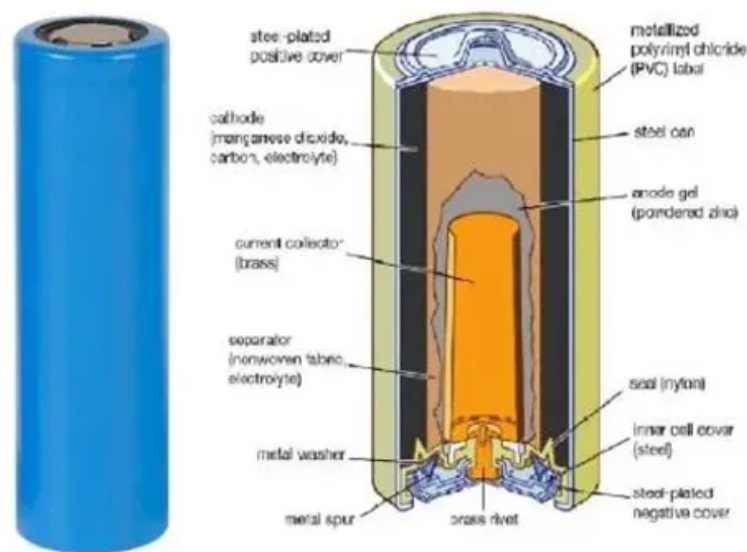

Liechtenstein import tariffs on solar container lithium battery energy storage



Overview

When will Chinese-origin lithium-ion non-EV batteries be taxed?

Tariffs on Chinese-origin lithium-ion non-EV batteries are scheduled to increase to 25% effective Janu. Otherwise, batteries of non-Chinese origin storage batteries have not been subject to multi-front targeted tariff or duty actions.

Will China impose tariffs on lithium-ion EV batteries?

An interesting issue will be the imposition of tariffs. There are existing tariffs pursuant to Section 301 of the Trade Act of 1974 on some Chinese-origin lithium-ion EV batteries and non-lithium-ion battery parts, which were increased to 25% in September 2024.

Are importers subject to VAT in Liechtenstein?

Importers in Liechtenstein are subject to Value Added Tax (VAT) and may incur customs duties based on the tariff classification of the goods. It is advisable to engage with a customs broker who can assist in the calculation and payment of these fees, ensuring compliance with the relevant legal frameworks.

Does Liechtenstein have a customs tariff?

In Liechtenstein, tariffs are administered in accordance with the European Union (EU) regulations, as the country is a member of the European Economic Area (EEA). Consequently, the tariff rates often align with those of the EU's Common Customs Tariff.

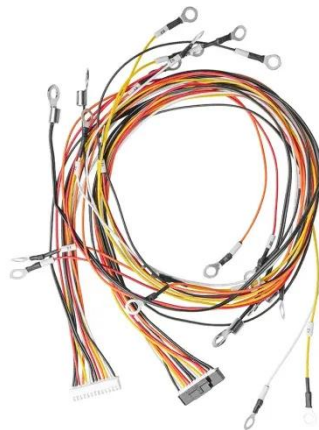
