Overview

What tariffs are imposed on Chinese solar cells & modules?

The U.S. had imposed several trade barriers against Chinese solar cell and module imports. In addition to the original 25% tariff under the Section 301, there are anti-dumping and countervailing duties (AD/CVD) that have been imposed since 2012 as well as the Section 201 tariffs targeting cells and modules from all countries.

Coalition trade lawyer says the U.S. Department of Commerce's final tariffs on solar cells and modules from Cambodia, Malaysia, Thailand and Vietnam are among the highest rates he's ever seen. From pv magazine USA.

Which solar companies got tariffs in Cambodia?

In contrast, four manufacturers in Cambodia—Hounen Solar, Jintek Photovoltaic, ISC Cambodia, and Solar Long PV Tech—got tariffs of 3,521.14%. The Southeast Asian country stopped cooperating with the U.S. probe, leading to such high penalties. The U.S. International Trade Commission will make a final determination on tariff rates on June 2.

How much solar equipment will Malaysia import in 2024?

Countrywide rates for Malaysia were posted at 34.4 per cent. The US imported US\$12.9 billion (S\$16.8 billion) in solar equipment in 2024 from the four countries that would be subject to the new duties, according to BloombergNEF. That represents about 77 per cent of total module imports.


