## Overview

Which solar companies do not incur import tariffs?

Other “Domestic” Suppliers: A few manufacturers with U.S.-based production or assembly – such as Hanwha Qcells (Georgia factories), First Solar (Ohio), Mission Solar (Texas), and Silfab (Washington) – do not incur these import tariffs on their U.S.-made panels. They have an effective price advantage now.

Does Octopus offer a tariff on solar panels?

Rates vary widely but, on average, solar panel owners are still receiving far less for their exported electricity than companies charge to supply it. One exception to this is Octopus's Intelligent Octopus Flux tariff, which is a smart time-of-use tariff with peak and off-peak pricing, where import and export rates always match.

How much do solar panels cost to export?

Find out which energy companies have the best rates. The amount you can get paid for exporting energy from your solar panels varies from a paltry 1p to 25p per kWh. That means that if you've got solar panels, choosing the best export tariff could earn you hundreds of pounds extra in payments every year.

Which solar companies are exempt from US tariffs?

For instance, REC Group (Singapore) panels carry only a 10% tariff; JA Solar's new factory in Phoenix (if operational) would be exempt entirely; and Waaree Energies (India) indicated the 27% U.S. tariff on Indian goods is manageable and hasn't changed their near-term pricing strategy.
