What is a procurement contract?

A procurement contract is a legal agreement defining each party's roles, responsibilities, and expectations for a project that binds a buyer and seller. A procurement contract minimizes risks in transactions by establishing legal safeguards, while also creating a foundation for secure and trustworthy business relationships.

What are the different types of procurement contracts?

While every procurement contract looks slightly different — reflecting the specific needs of your organization — most agreements fall into one of three broad contract types. 1. Fixed-price contracts The fixed-price contract is the most straightforward of all procurement agreements.

What is a solid procurement contract?

Solid procurement contracts include payment dates and terms, outline performance control measures, and discuss what should happen in the event of a dispute between the two parties. This is the most basic element of a procurement contract, outlining the vendor's responsibilities for delivering products and services.

What are the different types of fixed-price procurement contracts?

Depending on your relationship needs (and your supplier's requirements), you can use one of three fixed-price procurement contracts: Firm fixed-price (FFP): In an FFP contract, you simply pay for what you get.
