Section 201 Safeguard Tariff: Expired in Feb 2022 (no longer applies). Merchandise Processing Fee (MPF): 0.3464% of shipment value (min \$27.23, max \$538.40).

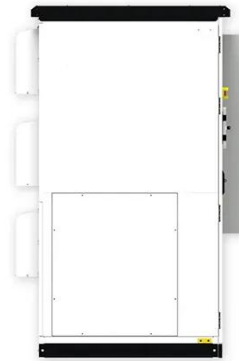
