

How to setup rooftop solar power projects in Sri Lanka?

Solar Panel Supplier should be a registered entity with 'Sri Lanka Sustainable Energy Authority' (SLSEA) and applicant should possess a valid Initial clearance letter. To setup rooftop Solar Power projects as specified below, Installation of solar panels to the Business premises. Commercial scale Rooftop solar power projects.

What is solar panel subsidy scheme in Karnataka?

The Indian Government solar panel scheme in Karnataka is a bit different than other states. This scheme is called 'Surya Raitha (Solar pump) subsidy scheme. If a farmer uses a solar pump in their field for farming activities the state government will provide subsidies to farmers.

Does Kerala offer a solar panel subsidy?

The State Government announced a solar panel subsidy of Rs 15,000/kW for rooftop projects for residential installations. Kerala: Under the government solar panel scheme, the Kerala state electricity board is offering up to 40% subsidy on L1 prices. The state has been allotted a 50 MW capacity installation target.

What is solar panel subsidy in India?

Solar panel subsidy in India is offered for made-in-India, ALMM-approved solar panels only. On-grid solar systems are the only candidates for a solar panel subsidy. Subsidy for residential solar is capped at 10 KW. Commercial settlements cannot avail of a solar panel subsidy. Only individual homes and housing societies are eligible.


