

# **Tax rates for selling solar panels**

Are solar panels taxable?

If the solar panels are fitted to a private residence, this income will be tax free, but businesses and landlords that rent out the accommodation need to be aware that their payment will be seen as taxable income, subject to income tax or corporation tax as appropriate.

Do I have to pay a sales tax on solar energy?

The solar sales tax exemption ensures you won't have to pay a sales tax on most of your system's equipment. If you use solar energy as a source of power, you won't need to pay a property tax for on the value added from solar. The average property tax in Indiana is 0.75%.

How much would a solar tax cost per year?


The CPUC's latest solar tax proposal would cost users between \$300 and \$600 per year. It's important to note that the less electricity you use, the more you would pay in solar taxes. Karinna Gonzalez, who works for a clean energy non-profit organization in San Diego, added solar panels back in December when she heard of CPUC's first solar tax proposal for all new solar customers.

Are solar power projects tax-free?

In other cases of solar power projects, tax avoidance is seen by tax authorities. Solar power generating systems (SPGS) are taxed at the rate of 5% and other supplies are to be taxed at the rate of 18%, but technically law does not define SPGS.




